Alappuzha U/s.232 (a) of Bharatiya Nagarik Suraksha Sanhita, 2023
(BNSS)

This case coming on for hearing today, the court passed the following:

ORDER

1. This is a case charge sheeted by the Sub Inspector of Police, Thrikkunnappuzha Police Station in Crime No. 718/2025 against the accused alleging the commission of offences punishable U/ss.76, 332(c), 126(2), 115(2) 74, 75 and 351(3) of BNS. The investigating officer filed final report on 14.01.2026.
2. The case of the prosecution is the following:- On 20.10.2025 at 7:10 AM, the accused criminally trespassed into the house of the defacto complainant house no. 3/2025 situated at Ambalasseri kadavu and with sexual intention the accused tore the nighty worn by the defacto complainant and used criminal force against her with an intention to outrage her modesty. Thereby the accused had committed the above said offences.

3. Accused appeared before court and was enlarged on bail. On his appearance, the copies of relevant records relied on by the prosecution were furnished to him.
4. On a perusal of the available materials, it appeared to this court that the above case is triable exclusively by a Court of Session.
5. Therefore, the case against the accused is hereby committed to Court of Session, Alappuzha U/s. 232 of BNSS.
6. The accused is released on bail with direction to appear before the Court of Session, Alappuzha as and when called for U/s.232 (a) of BNSS.
7. The records shall be forwarded to the Hon'ble Sessions Court, Alappuzha and the property produced if any/shall be send subject to Rule 77(2) of the Criminal Rules of Practice, Kerala at the earliest.
8. The Public Prosecutor, Alappuzha shall be notified regarding the committal of the case U/s.232 (d) of BNSS.
