Order : *Interim order passed.*

This C.M.P. having been heard today, the Court passed the following:-

ORDER

1. This petition is filed u/s.23 of the Protection of Women from Domestic
Violence Act, 2005.
2. First petitioner represented. Perused the affidavit filed by the first petitioner.

Heard the learned counsel for the petitioners.

3. I am satisfied that the application prima facie discloses that there is a likelihood that the respondents may commit acts of domestic violence. Hence, interference of this court is highly necessary for the protection of the petitioners/aggrieved person from domestic violence. Hence, invoking power u/s.23 of Protection of Women from Domestic Violence Act 2005, the following exparte ad interim order is passed:-

1. Respondents are hereby restrained from harming or injuring or endangering the health, safety, life or limb of the aggrieved persons or from causing any act of physical or verbal or emotional violence against the petitioners through telephone or otherwise. Respondents are hereby restrained from aiding or abetting the commission of the same.
2. Respondents are restrained from interfering with the peaceful residence of the petitioners at Kaipallil Tharayil, Ward No-7, Muthukulam South Muri, Muthukulam Village, as stipulated under Section 19(1)(a) of the Act.
3. Communicate the order free of costs to the parties, SHO., concerned.
4. Office shall comply with Section 24 of the Protection of Women from Domestic Violence Act.
