This petition coming on for hearing on 11.03.2026 and the court of the same day passed the following.

**ORDER**

Heard the petitioner.

Perused the affidavit in support of injunction petition, plaint and documents. I am satisfied that a prima facie case is made out justifying the grant of an ad-interim order of injunction. Prima facie, the balance of convenience is found in favour of the petitioner. If interim order is not granted, irreparable injury is likely to be caused to the petitioner. Delay in sending the notice will defeat the object of granting the relief. Hence an ad-interim order for injunction is passed restraining the respondents and men under them from trespassing into the plaint schedule property and building and not to forcefully evict the plaintiffs and tenants in such a manner to cause obstruction to the peaceful enjoyment of the plaint schedule property or from committing any mischief or waste on the plaint schedule property and shop rooms until further orders.
