JUDGMENT

1. This case is instituted upon the final report submitted by the State of Kerala (Police) alleging commission of offence punishable U/Sec 4, 6 of PUBLIC WAYS (RESTRICTION OF ASSEMBLIES AND PROCESSION) ACT, 2011 , U/Sec 189(2), 190, 191(2), 285 of Bharatiya Nyaya Sanhita .

2. The A1,A5 is present. The particulars of the above said offence are read over and explained to the Accused to which Accused pleaded guilty. I am satisfied that the plea is made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

3. The A2 is absent. Accused pleaded guilty through counsel to the charge framed for the above said offence. I am satisfied that the plea is made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

In the result, the Accused A1, A2, A5 convicted for the offence punishable under Section 189(2), 190, 191(2), 285 of the Bharatiya Nyaya Sanhita and Accused is sentenced to pay

a fine of Rs.600/-. In case of the default of the Accused A1, A2, A5 in paying the said fine amount, Accused shall undergo simple imprisonment for 6 Days.

Case against remaining accused A3, A4, A6 is refiled with Registration No:CC 437/2026.
