ORDER

The Final Report was filed against the accused by Excise Inspector, Excise Range Office, Nooranadu alleging commission of offences punishable under Sections 55(i) of Abkari Act, 1077.

2. The prosecution case, in brief, is as follows:- On 01.10.2025 at about 12.30 PM the accused was found in possession of 700 mililiters of Indian Made Foreign liquor at Aksah Bhavanam, for the purpose of sale, in contravention of the provisions of the Abkari Act, 1077. Hence the accused committed the aforesaid offences.

3. On filing the final report, the case was taken on file as C.P. No. 17/2026 and process was issued to the accused pursuant to

which she appeared before the Court. The accused was released on bail. Copies of the prosecution records were furnished to him.

4. I have perused the entire prosecution records. The offences alleged to have been committed by the accused is exclusively triable by the Hon'ble Court of Sessions. Hence, the case against the accused is committed to the Hon'ble Court of Sessions, Alappuzha as contemplated under Section 232(a) of the Bharathiya Nagarik Suraksha Sanhitha, 2023.

5. The entire records and material objects, if any, shall be forwarded to the Hon'ble Court of Sessions forthwith as contemplated under Section 232(c) of the Bharathiya Nagarik Suraksha Sanhitha, 2023. The accused shall appear before the Hon'ble Court of Sessions, Alappuzha as and when the Court directs.

6. Issue notice to the Public Prosecutor, Alappuzha regarding the committal of this case as contemplated under Section 232(d) of the Bharathiya Nagarik Suraksha Sanhitha, 2023.
