Offence : U/ss.27 (B) of Narcotic Drugs and Psychotropic Substances Act, 4(2)(j), 4 (2)(f), 5 of Kerala Epidemic Diseases Ordinance, 2020

Plea : Guilty

Finding : Guilty

Sentence : Accused is sentenced to pay fine of Rs 3000./- for offence U/s. 27 (B) of Narcotic Drugs and Psychotropic Substances Act, 4(2)(j), 4 (2)(f), 5 of Kerala Epidemic Diseases Ordinance , 2020 Act and in default, to undergo simple imprisonment for 15 days.

This case having been heard today, the court passed the following:-

J U D G M E N T

1. This case stands charge sheeted by the S.I. of Police, Nedumudy in Crime No. 187/2021 against the accused alleging commission of offence punishable U/ss. 27 (B) of Narcotic Drugs and Psychotropic Substances Act, 4(2)(j), 4 (2)(f), 5 of Kerala Epidemic Diseases Ordinance , 2020.
2. The accused produced before court. Copies of all the prosecution records were furnished to him as envisaged u/s. 207 Cr.P.C. Particulars of offences punishable U/ss. 27 (B) of Narcotic Drugs and Psychotropic Substances Act, 4(2)(j), 4 (2)(f), 5 of Kerala Epidemic Diseases Ordinance ,

2020 read over and explained to the accused. He pleaded guilty. Since the plea is voluntarily made, the same is accepted. The accused is found guilty of the offence punishable U/ss. 27 (B) of Narcotic Drugs and Psychotropic Substances Act, 4(2)(j), 4 (2)(f), 5 of Kerala Epidemic Diseases Ordinance , 2020 and he is convicted thereunder.

3. In the result, the accused is sentenced to pay fine of Rs. 3000/- for the offence punishable U/ss. 27 (B) of Narcotic Drugs and Psychotropic Substances Act, 4(2)(j), 4 (2)(f), 5 of Kerala Epidemic Diseases Ordinance , 2020 and in default, to undergo simple imprisonment for 15 days.
