JUDGMENT

1. This case is instituted upon the final report submitted by the State of Kerala (Police) alleging commission of offence punishable U/Sec **189(2), 191(2), 190, 329(3), 126(2)** of **Bharatiya Nyaya Sanhita** .

2. The A2,A6,A10,A12,A13 is absent. Accused pleaded guilty through counsel to the charge framed for the above said offence. I am satisfied that the plea is made voluntary. Hence the plea of the Accused are accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

In the result, the Accused A2, A6, A10, A12, A13 convicted for the offence punishable under Section 189(2), 191(2), 190, 329(3), 126(2) of the Bharatiya Nyaya Sanhita and Accused are sentenced to pay a fine of Rs.3000/- each. In case of the default of the Accused A2, A6, A10, A12, A13 in paying the said fine amount, Accused shall undergo simple imprisonment for 1 Month.

Case against remaining accused A1, A3, A4, A5, A7, A8, A9, A11 is refiled with
Registration No:CC 623/2025.
