ORDER

2. The counsel for the appellant submitted that there is every chance to allow the appeal in his favour and if the extension of stay is not granted, he will be put to irreparable injury, loss and hardship.

3. I have perused the averments in the petition and appeal memorandum. Somany grounds are mentioned in the appeal to challenge the impugned order and if stay order is not extended, he will be put to irreparable injury, loss and hardship. Hence the petition is allowed and the stay is extended till 10/03/2025 and the operation of all further proceedings in E.P.No.17/2013 in O.S. 1297/1993 pending before the Principal Munsiff's Court, Ernakulam is stayed till 10/03/2025.
