COMMITMENT ORDER:

The above named accused have been sent up by the
Officer Incharge of PS Model Town, Hoshiarpur, to face trial for
offences under sections 379B,411 IPC.

2. The brief facts of the case are that complainant
Lakhwinder Singh is painter by profession. On 19.10.2018 at about
5.30 P.M. he alongwith his friends Bablu, Pappu Kumar and Rajesh
Kumar were sitting in the Football Ground at Dashmesh Nagar,
Hoshiarpur and had to go to see Dushehra festival. In the

meanwhile, one motorcycle on which three young boys were riding came from behind and by showing sword, they snatched ₹7,000/- from the pocket of the complainant, ₹ 3500/- from the pocket of Bablu, ₹ 2500/- from the pocket of Papu Kumar and ₹ 4000/- from the pocket of Rajesh Kumar. They identified the culprits as Charanjit Singh, Ashwani Kumar and Jatinder Singh Cheema, as they used to meet them in the play ground. On crying for help by the complainant and his companion the above said persons fled away on their motorcycle. In the end prayer for taking action against the accused was made. During the investigation the I.O. visited the spot and prepared the site plan, accused Ashwani Kumar and Charanjit Singh were arrested and their arrest-cum-information memos were prepared, personal search of accused was conducted and memos were prepared in this regard, during the interrogation the accused suffered disclosure statements, the accused were got identified and identification memo was prepared, currency notes of ₹ 500/- were recovered from accused Ashwani Kumar and the same were taken into possession vide separate memo, currency notes of ₹ 500/- were recovered from accused Charanjit Singh and the same were taken into possession vide separate memo, site plans of place of recovery were prepared. The I.O. recorded the statements of witnesses U/s 161 Cr. PC. Accused Jatinder Singh Cheema could not be arrested and upon completion of

investigation challan was presented against accused Charanjit Singh and Aswani Kumar.

3. Copies were supplied to the accused free of costs, as required U/S 207 Cr. PC.

4. After hearing Ld. APP for the State, Ld. counsel for accused and after going through the report under section 173 Cr.P.C., it appears that prima facie accused have committed an offence punishable under sections 379B,411 IPC and offence under section 379B IPC is exclusively triable by the Ld. Court of Sessions. Accordingly, the present case is committed to the Court of Ld. Sessions, Hoshiarpur, for 25.01.2019. The Accused, who are on bail are directed to appear before Court of Ld. Sessions Judge, Hoshiarpur at 10.00 A.M. sharp on 25.01.2019. The office of Ld. District Attorney is apprised of the contents of this order through Ld. Addl.P.P, Hoshiarpur who is present in the Court. Ahlmad/Reader are directed to complete the file in all respects and then Ahlmad shall send the file well in advance to the Court of Ld. Sessions Judge, Hoshiarpur, for 25.01.2019
