This reference is made under Sec.64 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Re-settlement Act, 2013.

2. The claimants appeared and filed a claim statement. For the last 4 postings there was no representation from the side of the claimants. The claimants had not adduced any evidence to prove that the compensation awarded to them is inadequate. Now there is no material to prove that the compensation awarded to the claimants is inadequate

3. In the result, an award is passed holding that the claimants are not entitled to get any amount as enhanced compensation.
