This petition filed to suspend the order of sentence dated 29.11.2025 in ST No.178/2023 of Additional Chief Judicial Magistrate Court (MP/MLA), Ernakulam.

This petition coming on for hearing on 29.12.2025 and the Court on the same day passed the following:

**ORDER**

This petition is filed by the appellants to suspend the execution of the sentence imposed on them by the trial court.

2. Heard the counsel for the appellants.
3. Now the appeal has already been admitted. The appellant has an

arguable case. Therefore in the interest of justice the execution of the sentence is liable to be suspended till the final disposal of the appeal.

In the result, the execution of the sentence imposed on the appellants in ST No.178 of 2023 on the file of the Additional Chief Judicial Magistrate Court (MP/MLA), Ernakulam, is suspended till the disposal of the appeal, on the appellants executing a bail bond for ₹50,000/- (Rupees Fifty Thousand only) each with two solvent sureties each for the like sum before the trial court.
