This petition filed to return the passport of the petitioner and permit him to go abroad to pursue the opportunity.

This Petition coming on for hearing before me on 29.09.2025 and the court on 06.10.2025 passed the following:-

**ORDER**

Petition to release passport.

2. Petitioner is the accused in S.C. No.354/2025 on the file of this court. Offences alleged against the petitioner are under Sections

22(b) and 22(a) of NDPS Act. According to the petitioner he was granted bail by Hon'ble Sessions Court, Ernakulam and he surrendered his passport in compliance with the bail condition. He seeks release of the passport to leave India to provide coaching to a sports club based in UAE.

3. Notice given to the Public Prosecutor.

4. Objection filed.

5. Heard both sides.

6. Petitioner has stated that he is a sportsman and he has got an opportunity to provide coaching to a sports club in UAE. This case is of the year 2025 and it is not likely that this case will be taken up for trial within next one year.

7. Considering the above facts, this petition can be allowed in part on conditions.

8. Hence, this petition is allowed in part on the following conditions :-

- 1) Petitioner shall execute bond for ₹1,00,000/- (Rupees One lakh only) with two solvent sureties each for the like sum.

- 2) On execution of the bond as above, petitioner's passport will be released to him for a period of one year from 10.10.2025.
- 3) Petitioner shall surrender his passport before this court on the expiry of above period of one year.
