This petition filed under Section 439(1)(b) Cr.P.C. to release the accused  
on modifying the first and second conditions.

These Petitions coming on for hearing before me on 07.01.2026 and the  
court on 09.01.2026 passed the following:-

**ORDER**

Petition to modify bail condition.

2. Petitioner is accused in S.C. No.1538/2024 on the file of this Court,  
arising out of Crime No.1152/2024 of Aluva East police station. The offence  
alleged is punishable under Section 103(1) of BNS.

3. The prosecution case, in brief, is that due to the previous enmity  
due to the quarrel between the petitioner and the deceased Krishnankutty, on

03.07.2024 at 5.00 AM at Paravur Kavala in Thottakkattukara, petitioner committed murder of the deceased by stabbing him with scissors.

4. Petitioner was granted bail by this court as per order dated 21.10.2025 in CrI.M.P. No.2667/2025. Petitioner seeks modification of the bail conditions.

5. Notice given to Public Prosecutor.

6. No objection filed.

7. Heard both sides.

8. Petitioner was granted bail by this court by the following conditions:

- 1) Petitioner/accused shall execute bond for ₹1,00,000/- (Rupees One lakh only) with two solvent sureties each for the like sum.
- 2) The sureties shall produce copy of their title deeds and also make available original title deeds for verification to show that they have landed properties.
- 3) Petitioner shall surrender his passport. If he has no passport, he shall file an affidavit to that effect.
- 4) Petitioner shall not enter the limits of Aluva East Police Station till the conclusion of trial.
- 5) Petitioner shall not influence or intimidate witnesses.
- 6) Petitioner shall not involve in any offence while on bail.

7) If any of the condition is violated, bail granted is liable to be rejected.

9. According to the petitioner, he is to released on a single surety and sureties are to be exempted from producing title deed.

10. The offence alleged against the petitioner is of serious nature. Presence of petitioner at the time of trial is to be ensured. Considering the nature of the offence alleged, the condition that petitioner shall produce two solvent sureties cannot be modified. However, the direction that the sureties shall produce original title deed can be modified as the sureties shall produce copies of title deeds.

11. In the result, this petition is allowed as follows :-

- (1) The prayer to modify the condition that petitioner shall produce two solvent sureties is rejected.
- (2) Condition No.2 is modified as follows : The sureties shall produce copies of their title deeds.
