The CMP coming today for hearing, the court passed the following:

**ORDER**

This is an application filed by the petitioners claiming various reliefs against the respondent u/s. 23 of Protection of Women from Domestic Violence Act 2005.

2. Heard the counsel for petitioner. Perused the application, affidavit and

copies of documents.

3. I am satisfied that there are prima facie grounds to proceed against the respondent under the provisions of Protection of Women from Domestic Violence Act. Therefore this court is of the view that an urgent ex parte order of protection is to be granted in favour of the petitioners.

Hence, an interim order is passed as follows:

(1) The respondent is hereby restrained from committing any act of domestic violence against the petitioners until further orders;

Communicate this order to the SHO, Aluva West Police Station and the Protection Officer concerned.

All other reliefs sought will be considered later. Issue notice to the respondent on 29.12.2025
