This petition is filed under Order 39 Rule 1 & Section 151 of Civil Procedure Code 1908 to pass an order of injunction restraining the defendant and her men or agents from cut and remove the valuable trees in the plaint schedule properties, dispossessing the plaintiff from the plaint schedule properties, disturbing the peaceful possession and enjoyment of the plaint schedule properties by the plaintiff, alienating the plaint B & C schedule properties to strangers and from making any encumbrance with respect to the plaint B & C schedule properties till the final disposal of the suit and is coming on for final hearing on 29.05.2024 in the presence of the petitioner's counsels and the Court on the same day passed the following:-

ORDER

Heard the learned counsel for the petitioner. Perused affidavit and copies of documents produced in support of the petition. I am satisfied that the petitioner has made out a prima facie case and delay in issuance of notice will defeat the purpose

of granting injunction. Hence, an ad-interim injunction is passed restraining the respondent from cutting and removing valuable trees from the plaint schedule properties, alienating petition B and C schedule properties and committing waste therein till 12.06.2024.

Issue notice to the respondent. Comply Order XXXIX Rule 3 of CPC.
Communicate the copy of this order to the Village Officer and the SRO concerned.
