1. This is bail application filed by Mr. Joel Zosangliana S/o J.C. Vanlalvuana (L), Farkawn, Champhai District u/s 439 of Cr PC r/w 37 of ND&PS Act in connection with Sairang PS Case No. 12 of 2021 Dt. 2.11.2021 u/s 21 (c) of ND&PS Act, 1985 after rejection of his previous Bail Appln. No. 1387 of 2021 on dt. 9/12/2021.
 2. On hearing the rival contentions of learned counsel for the accused petitioner

and learned Addl. PP at length and on perusal of their application, except pre and post charge-sheet stages, no new grounds and reasons are found in the instant bail application. In short, the reasons/grounds in the instant bail application is already rejected by this court in the previous bail rejection order in Bail Appln. No. 1387 of 2021 on dt. 9/12/2021.
