This petition coming on for hearing today, the court passed the following :-

ORDER

This petition filed U/s.23(2) of the Protection of Woman from Domestic Violence Act, 2005.

2. Heard the Counsel for the petitioners and perused the affidavit and records.
3. On the basis of the affidavit and documents produced, I am prima facie satisfied that domestic violence has taken place and is likely to take place. Hence the following interim reliefs are granted.

1. Restraining the respondent from evicting the petitioners from the use and occupation of the residential house in No.3/66 of Edakkattuvayal Gramapanchayath, situated in 2.02 Ares of property in Sy No.103/12 in Edakkattuvayal Village in Block No.25 as per the sale deed of 1201/2010 of SRO Piravom.

2. Restraining the respondent from committing, aiding and abetting any act of domestic violence against petitioners at the residential house at No.3/66 of Edakkattuvayal Gramapanchayath, situated in 2.02 Ares of property in Sy No.103/12 in Edakkattuvayal Village in Block No.25 as per the sale deed of 1201/2010 of SRO Piravom.

3. Other reliefs can be considered after hearing both parties.

4. Communicate copy of order to the respondent.

5. SHO, concerned shall give necessary assistance to the petitioners in implementing the order. Issue notice to respondent.
