ORDER

This case is instituted on the final report filed by the Sub Inspector of Police, Ambalamedu Police Station in Crime No.153/2024. The offences alleged against the accused are punishable under Sections 332(c), 78, 74, 75(i) and (ii), 351(3) and 238 of Bharatiya Nyaya Sanhita, 2023.

2. **The case of the prosecution in nutshell is as follows:-** The accused persistently insisted that the defacto complainant accompany him with the intention of sexually abusing her. Owing to enmity arising from her interaction with her

friends, he allegedly slapped her on the cheek in a public place. Despite the defacto complainant having clearly expressed her disinterest, the accused continued to follow and harass her. Subsequently, on 19.03.2025 at about 3.00 p.m., the accused allegedly criminally trespassed into the residence of the defacto complainant and compelled her to accompany him. When she refused to comply, he criminally intimidated her by threatening to kill her and her family members. The accused thereby committed offences punishable under Sections 332(c), 78, 74, 75(i) and (ii), 351(3) and 238 of the Bharatiya Nyaya Sanhita, 2023.

3. Accused appeared before the Court and he is on bail. Copies of relevant prosecution records were furnished and thereby complied with Section 231 of Bharatiya Nagarik Suraksha Sanhita, 2023.

4. On perusal of the case records, it appears to me that one of the offences alleged against the accused is exclusively triable by the Court of Sessions. Hence I commit the case against accused under Section 232 of Bharatiya Nagarik Suraksha Sanhita, 2023 to the Hon'ble Court of Sessions, Ernakulam.

5. Office is directed to sent the case records to the Hon'ble Court of Sessions, Ernakulam, forthwith. Properties and Forensic report shall be sent to the Hon'ble Court of Sessions as and when required. Notify the committal of the case to the Public Prosecutor. The accused shall appear before the Court of Sessions as and when required by that court.
