ORDER

Heard learned counsel for the petitioner. Perused the records. I am satisfied that the petitioner has made out a prima facie case. The balance of convenience lies in his favour. The object of granting injunction will be defeated if notice is issued before granting injunction. Hence the respondents are hereby restrained from evicting the plaintiff forcibly other than due process of law from plaint schedule properties and from interfering with the peaceful possession and enjoyment of plaint schedule properties until further orders. The petitioner shall comply with the proviso under Order 39 Rule 3 of the Code of Civil Procedure. Issue notice to the respondents. Take steps. For return of notice to 06/12/2025.
