This petition coming on this day for hearing before me in the presence of Sri.P.Venugopalan, Advocate for Petitioners; Public Prosecutor for the Respondent (State); the Court passed the following:

Heard.

2. Today, when the matter came up for further consideration, Adv.Sreeja Athayil, the learned counsel appearing for the petitioners/appellants submitted that the petitioners/appellants are coolie labourers, who are unable to find out income to remit 50% of the fine amount, as ordered by this court. He therefore prays for modifying the impugned orders by reducing 50% of the fine amount to 10%.

3. Having considered the facts and circumstances and the reasons stated by the learned counsel appearing for the petitioners, I am inclined to reduce the amount of fine ordered to be deposited by this court as per order dated 11.11.2025 in Cr1.MP No.6427/2025 from 50% to 30%,

which shall be remitted on or before 18.12.2025. I order accordingly.

In the result, the amount of fine ordered to be deposited by this court as per order in Cr1.MP No.6427/2025 stands reduced to 30% of the fine amount.

The petitioner is granted further time upto 18.12.2025 for complying the order of this court.
