Heard.

2. At the hearing, Mr.A.N.Ashok Kumar, the learned counsel appearing for the petitioners/appellants argued that the appellants have got good ground to contest the matter in the appeal. He therefore prays for suspension of sentence imposed against the appellants as per the impugned judgment.

3. Having considered the facts and circumstances of the case and the nature of sentence imposed, I am of the view that the execution of impugned sentence passed against the petitioners/appellants is liable to be suspended until further orders. I order accordingly.

In the result, the execution of sentence against the petitioners/appellants in CC.No.980/2018 on the file of the Court of Judicial First Class Magistrate-II, Kasaragod stands suspended on their executing a bond for ₹25,000/- (Rupees Twenty Five Thousand only) each with a solvent surety for the like sum, and also on their depositing 50% of the fine amount before the trial court on or before 12.12.2025.
