JUDGMENT

1. This application is filed for issuance of heirship certificate under Bombay Regulation Act.
2. Sister of the applicant viz. Nirmala Sunil Patil died on 02.05.2021. Her husband Sunil Baburao Patil also died on 03.11.2021. The couple was died issueless. Opponent No.1 is the mother and opponent No.2 is the brother of deceased Nirmala Sunil Patil. Now applicant, opponent Nos.1 and 2 are the legal heirs of deceased Nirmala Sunil Patil. Name of deceased Nirmala Sunil Patil was recorded on 7/12 extract of land Gut No.307 situated at Madhavnagar, Tal. Miraj, Dist. Sangli.
3. Applicant filed on record 7/12 extract of land Gut No.307 (Exh.16) and death certificates of Nirmala Sunil Patil and Sunil Baburao Patil (Exhs.17 and 18).
4. Paper/Public notice (Exh.19) was issued, but nobody came forward to raise objection.
5. Applicant Pravin Ramchandra Jadhav deposed at Exh.13.
6. It is proved that applicant and opponent Nos.1 and 2 are the legal heirs of deceased Nirmala Sunil Patil. To sum-up, I pass following order.
