ORDER

This is a case in which final report was filed by the Excise Inspector of Nadapuram Excise Range in Crime No:104/2024 alleging commission of offence Punishable U/s.55(i) of Kerala Abkari Act.

2. The case of the prosecution in brief is as follows: On 03.09.2024 at 6.15 p.m at the road margin of Kuttiady-Nadapuram state highway, in front of the shop named PB Store at Mokery, the accused was found in possession of 3 litres of Indian Made Foreign Liquor for the purpose of sale. Thus, the accused is alleged to have

committed the above mentioned offence.

3. The accused was released on bail at the crime stage. On appearance of the accused before the Court, he was permitted to continue on the bail bond executed at the crime stage. Copies of relevant prosecution records were furnished to him and procedure U/s. 230 of BNSS is complied with.

4. The offence alleged against the accused is triable exclusively by the Hon'ble Court of Session. In the result, the case is committed to the Hon'ble Court of Session, Kozhikode U/s. 232(a) of BNSS for trial.

5. Transmit the entire case records to the Hon'ble Court of Session, Kozhikode.

6. Transmit the properties if any to the Hon'ble Court of Session, Kozhikode as and when required by that court.

7. The accused is on bail. He is directed to appear before the Hon'ble Court of Session, Kozhikode as and when required by that court.

8. The factum of committal of the case shall be notified to the Public Prosecutor, Kozhikode.
