### **ORDER**

The accused person herein stands charged having committed offences punishable U/s. 58 of Abkari Act.

2. **Prosecution case in brief is as follows:-** On 13.09.2024 at about 6.35 p.m., at Platform No. 1 of Kozhikode Railway Station, about 7 metres east of the board marked "Towards Shoranur Coach Position 13 from Engine," the accused was found in possession of 66.750 litres of Indian Made Foreign Liquor permitted for sale only in the State of Goa. Thus, the accused committed the offence punishable under Sections 58 of the Abkari Act.

3. On appearance of accused, copies of all relevant case records were furnished to him u/S. 230 of BNSS. Accused is on bail. He was represented by Counsel of his own choice.

4. Since the final report disclosed commission of offences punishable U/S. 58 of Abkari Act which is exclusively triable by the Hon'ble Court of Sessions, committal proceedings were initiated against the accused and committed to the Hon'ble Court of Sessions, Kozhikode U/s.232(b) of BNSS.

5. The Public Prosecutor shall be notified of the commitment of the case.

6. Transmit the case records and material objects, if any, to the Hon'ble Court of Sessions, Kozhikode.

7. The accused is directed to appear before the Hon'ble Court of Sessions, Kozhikode, as and when required.
