The above case having come up for consideration on 24.09.2025 this Court on the same day delivered the following:-

ORDER

The accused person herein stands charged having committed offence u/Ss.13r/w 63 & 55(i) of Abkari Act.

2. The prosecution allegation is that, on 13.05.2025 at 12.20 PM, towards the Park road at Edodi-Vatakara, the accused was found possessing and selling of 6 litres of Indian made Foreign liquor and thereby committed the above offences. The Preventive Officer, Vatakara Excise Range Office and his party detected the offence, seized the contraband and arrested the accused from the spot.

3. The accused who was arrested and produced before this Court on 13.05.2025 was remanded to judicial custody at Sub Jail, Vatakara till 27.05.2025. He was represented by a Counsel of his own choice. Later he was granted bail by the Hon'ble Sessions Court, Kozhikode vide order in Criminal Miscellaneous Case no.812/2025 dated 04.06.2025.

4. On submission of final report, this Court has taken cognizance for the offence punishable under Section 13 r/w 63 & 55(i) of Abkari Act and issued summons to accused. Since the final report disclosed commission of offences punishable u/s.13r/w 63 & 55(i) of Abkari Act, one of which is exclusively triable by the Hon'ble Court of Sessions, committal proceedings were initiated against the accused.

5. On appearance, copies of all relevant prosecution records were furnished to the accused as contemplated u/S.230 of BNSS. Accused was permitted to continue on the bail bond executed during crime stage.

6. In the aforesaid circumstance, the case is committed to the Hon'ble Sessions Court, Kozhikode U/s.232(a), BNSS.

7. Transmit the case records and material objects, if any, to the Hon'ble Court of Sessions, Kozhikode forthwith.

8. Notify the Public Prosecutor, Kozhikode regarding the committal of this case to the Hon'ble Sessions Court, Kozhikode.

9. The accused person is directed to appear before the Hon'ble Court of Sessions, Kozhikode, as and when required.
