The above case having come up for consideration on 8.4.26 and this Court on the same day delivered the following:-

ORDER

The above case arose on a Final Report filed by Sub Inspector, Vatakara Police Station in Crime No.336/22 alleging commission of offences punishable U/Ss.341, 323, 324, 308, 294(b) r/w 34 of IPC.

2. The prosecution case is briefly stated as follows:- On 31.03.2022 at 19.00 hours, in the public road at Mukacheri, the accused persons, in furtherance of their common intention, had abused CW1 in obscene language. Further the accused no.2 had wrongfully restrained CW1 and the accused no.1 had voluntarily caused hurt to

him by beating with hand on his left cheek. Further the accused persons had voluntarily caused hurt to CW1 by beating all over the body of CW1. Further, the accused no.1 had attempted to commit culpable homicide not amounting to murder of CW1 by hitting on his head with a quarry stone. Thus the accused persons are alleged to have committed the above mentioned offences.

3. On receipt of final report, this Court has taken cognizance for the above offences and the case was taken on file as CP.61/2022 against 3 accused persons. Since Section 308 of IPC is exclusively triable by the Hon'ble Court of Sessions, committal proceedings were initiated against the accused persons. On receipt of summons accused nos.1 and 3 were appeared before court. The accused in this case was the second accused and he was absconding. Subsequently, case against accused nos.1 and 3 was committed to Hon'ble Sessions Court and case against accused no.2 was split up and refiled as CP.82/2022. Later case against him was transferred to LP as LP No. 107/23. Upon arrest and production of accused before court, the case was refiled from LP and numbered as CP No.115/2022, the present case. He was enlarged on bail and furnished with the copies of all relevant prosecution records as contemplated u/S.230 of BNSS.

4. In the aforesaid circumstance, the case is committed to the Hon'ble Sessions Court, Kozhikode U/s.232(a) of BNSS.

5. Submit the entire records of the case to the Hon'ble Sessions Court, Kozhikode.

6. Property if any, will be submitted to Hon'ble Court on getting intimation.

7. Notify the learned Public Prosecutor, Kozhikode regarding the committal of the above case to the Hon'ble Sessions Court, Kozhikode.
