Commitment Order:-

1 In the case in hand, accused Tejinderpal Singh has been sent up for facing trial for the commission of offence punishable U/s 376,506,120-B and 3/4 POCSO Act under P.S. Koomkalan, Ludhiana.

2. The brief facts of the prosecution case are that on 21/04/2018, ASI Sohan Singh alongwith police party was present at main chowk, Koom Kalan where one Nirmal Singh came present and suffered a statement to the effect that he is an agriculturist and has 3 daughters and 2 sons. In the month of March 2018, he had gone to Huzoor Sahib and he came back to his village Harian in the first week of April 2018. At that time, his younger daughter Gamandeep Kaur whose date of birth is 28/08/2000 looked scared and frightened. She told her mother that Tejinderpal Singh came present on 29/03/2018 at their house and raped her. He used to come present daily and used to rape her. He threatened her that he will kill her brothers if she reveals the incident to anyone. In the absence of the complainant, when his wife used to go away in connection with some work, the said accused Tejinderpal Singh used to come present and rape his daughter. The complainant had family ties with the accused and therefore he was a frequent visitor to the house of the complainant. The incident has been told to the complainant by his wife and accordingly he has suffered the said statement. Upon the statement of the complainant, a rukka was sent through Constable Amandeep Jakhu for registration of FIR and investigation was conducted. The site plan was prepared. The birth certificate and Aadhar Card of the victim Gamandeep Kaur was taken into police possession. On 23.4.2018, the medical of the victim was got

conducted. The statement of the victim was got recorded under Section 164 Cr.P.C. Statements of witnesses were recorded under Section 161 Cr.P.C. The accused was arrested on 24/04/2018. The offence under Section 120B IPC was added. The investigation is still going on with regard to the accused Daljit Kaur.

3 On appearing before the court, the accused was supplied with copies of challan and other documents free of costs as required U/s 207 CrPC.

4. The undersigned has heard the Ld. APP for the State and Ld. Defence counsel and has also carefully perused the file. The undersigned is not competent to try this case as the offences u/s 376 of the Indian Penal Code, 1860 and 3/4 of The Protection of Children from Sexual Offences Act, 2012 are exclusively triable by the Ld. Court of Sessions. Therefore, the case in hand is hereby committed to the court of Ld. District & Sessions Judge, Ludhiana for 15.9.2018. Accused alongwith counsel are directed to appear before the said Ld. court at sharp 9:30AM. Ahlmad is directed to complete the file in all respects and then to send the same to the court of Ld. District & Sessions Judge, Ludhiana, well before the date fixed. Prosecution agency be informed accordingly.
