This Petition coming on this day for hearing before me in the presence of Smt. Bindu. N, Advocate for Petitioners and Sri. Jayachandran Nandanassery, Advocate for Respondent No. 1 & 2 and AGP for Respondent No. 3 & 4 and Sri. M. Bindu, Advocates for Respondent No. 5 & 8 and Sri. G. Praveenkumar, Advocate for Respondent No. 6, 7 & 9 and the Court passed the following:

ORDER

1. Petition is filed under Order 1 Rule 10(2) and Section of Code of Civil Procedure.
2. Petitioners herein are third parties. Petitioners contends that the plaint schedule property as well as surrounding property belongs to Poomadathil Tharawad and as per partition deed No. 7/1962 of Sub Registrar's Office, Naduvannur, the properties belong to the Petitioners.

3. Respondent Nos. 1 and 2 filed Objection contending that the plaint schedule property belongs to Thrikuttysery Devaswom. The partition deed as alleged by Petitioners is invalid.
4. Heard both sides.
5. Petitioners herein contends that the Petitioners are the owners of the property as per partition deed No. 7/1962 of Sub Registrar's Office, Naduvannur. Although the suit is for injunction it is found that the interest of Petitioners will be affected and they have to be impleaded in the Petition for the proper adjudication of the dispute. IA allowed. IA closed.
