This Petition coming on this day for hearing before me in the presence of Sri. Lineeshkumar P.C, Advocate for Petitioners and Respondents not entered in appearance and the Court passed the following:

ORDER

1. Petition filed under Order 39 Rule 1 of the Code of Civil Procedure.
2. Heard the Petitioner. Perused the Petition and records. I am satisfied that the Petitioner has a *prima facie* case and the petition schedule property is in danger of being obstructed and damaged. If notice is issued to the Respondent, the object of granting injunction would be defeated by delay. Hence ad-interim injunction is granted. The Respondent/Defendant and their men are hereby restrained by way of temporary prohibitory injunction from trespassing into petition A schedule property or commit waste thereupon or obstruct the use of petition B schedule property by the Petitioner until further Orders.
3. The Petitioner shall comply with order XXXIX Rule 3. For return of notice to 02.06.2026.
