ORDER

The accused are facing trial for the offences punishable under SS.120B, 109, 143, 144, 147, 148, 452, 342, 323, 326, 364A, 365, 307 and 506(ii) r/w 149 IPC. The final report was filed by the Deputy Superintendent of Police, Vatakara.

2. The prosecution case, in brief, is that the accused conspired together and formed themselves into an unlawful assembly and in prosecution of the common object of the unlawful assembly, at 6.40 am on 13.07.2021, trespassed into the house of CW1 and CW2 bearing No. 8/411A of Arikkulam Panchayat at Kaitheri, threatened CW1 to CW3 using a gun and abducted CW2 and caused grievous hurt to him. Thereafter, the accused abandoned CW2. Hence the accused are alleged to have committed the aforesaid offences

3. A1 to A3 appeared on issuance of process. The copies of all relevant prosecution records were furnished to them and thereby mandate under S.230 BNSS was complied with. They were defended by a counsel appointed by them. They are on bail. The offences alleged are exclusively triable by a Court of Session. Hence, the case against A1 to A3 is committed to the Hon'ble Court of Session, Kozhikode under S. 232 BNSS. A4 and A5 are absconding.

4. Submit the entire records of the case to the Hon'ble Court of Session, Kozhikode and property, if any, shall be sent subject to Rule 77 (2) of Criminal Rules of Practice, Kerala.

5. Notify the Public Prosecutor of the commitment of the case to the Hon'ble Court of Session.

6. **Case against A4 and A5 is split up and refiled as CP No. 47/2025.**
