JUDGMENT

1. This case is instituted upon the final report submitted by the SHO Meppayyur alleging commission of offence punishable U/Sec 147 of IPC \ , U/Sec 145 of IPC \ , U/Sec 153 r/w 149 of IPC \ , U/Sec 143 of IPC \ .

2. The A2,A3,A4 is present. The particulars of the above said offence are read over and explained to the Accused to which Accused pleaded guilty. I am satisfied that the plea is made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

In the result, the Accused A2, A3, A4 convicted for the offence punishable under Section 143 of the IPC \ and Accused is sentenced to pay a fine of Rs.250/-. In case of the default of the Accused A2, A3, A4 in paying the said fine amount, Accused shall undergo simple imprisonment for 2 Days. The Accused A2, A3, A4 is further convicted for the offence punishable under Section 145 of the IPC \ and Accused is sentenced to pay a fine of Rs.250/-.
