JUDGMENT

1. This case is instituted upon the final report submitted by the SHO Meppayyur alleging commission of offence punishable U/Sec 147 of IPC \ , U/Sec 143 r/w 149 of IPC \ , U/Sec 283 of IPC \ .

2. The A1,A2,A3,A5,A8,A11,A12,A15,A16,A22 is present. The particulars of the above said offence are read over and explained to the Accused to which Accused pleaded guilty. I am satisfied that the plea is made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

In the result, the Accused A1, A2, A3, A5, A8, A11, A12, A15, A16, A22 convicted for the offence punishable under Section 143 r/w 149 of the IPC \ and Accused is sentenced to pay a fine of Rs.250/-. In case of the default of the Accused A1, A2, A3, A5, A8, A11, A12, A15, A16, A22 in paying the said fine amount, Accused shall undergo simple imprisonment for 2 Days. The Accused A1, A2, A3, A5, A8, A11, A12, A15, A16, A22 is further convicted for the offence punishable under Section 147 of the IPC \ and Accused is sentenced to pay a fine of Rs.250/-. In case of the default of the Accused A1, A2, A3, A5, A8, A11, A12, A15, A16, A22 in paying the said fine amount, Accused shall undergo simple imprisonment for 2 Days. The Accused A1, A2, A3, A5, A8, A11, A12, A15, A16, A22 is further convicted for the offence punishable under Section 283 of the IPC \ and Accused is sentenced to pay a fine of Rs.200/-. In case of the default of the Accused A1, A2, A3, A5, A8, A11, A12, A15, A16, A22 in paying the said fine amount, Accused shall undergo simple imprisonment for 2 Days.

Case against remaining accused A4, A6, A7, A9, A10, A13, A14, A17, A18, A19, A20, A21, A23, A24, A25 is refiled with Registration No:CC 337/2021.
