This OP coming on this day for hearing before me in the presence of above advocates and this tribunal passed the following:-

AWARD

1. This is an application under Section 166 of the Motor Vehicles Act, 1988 seeking compensation for a sum of ₹ 1,00,000/- (Rupees one lakh only) from the respondents.

2. The matter was referred to mediation. It was reported that the matter settled in mediation. I have perused the mediation agreement. The mediation agreement is lawful. Hence compromise recorded.

In the result, an award is passed in terms of the compromise as follows:-

1. An award is passed in favour of the petitioner for a sum of ₹ 50,000/-(Rupees Fifty thousand only).
2. The respondent No.3 shall deposit ₹50,000/-(Rupees Fifty thousand only) in the bank account of the petitioner with **Canara Bank, Parambil Bazar Branch (Account No: 4884101003803 IFSC code : CNRB0004884)** within 30 days from this date.
3. If the respondent No.3 fails to pay the amount as stated above, the petitioner is entitled to file execution petition to realise the said amount i.e., ₹ 50,000/- together with interest at the rate of 8% per annum from this date till the date of realisation.
4. Immediately after the deposit is made as stated above, the respondent No. 3 shall file a statement before this Tribunal regarding the compliance of the order.
5. The office of the Tribunal shall make necessary entries in the register of the Tribunal evidencing the payment of the amount to the petitioner.
6. Full court fee and Kerala Legal Benefit Fund shall be refunded to the petitioner.
7. That the mediation agreement do form part of the award.
