J U D G M E N T

This is a suit for realization of money.

2. The plaintiff filed this suit to realize an amount of Rs.6,37,399/- from the defendant and his assets along with 6% interest per annum.

3. The defendant though appeared in person failed to file written statement within the statutory period. Subsequently, the defendant was proceeded ex-parte.

4. To prove the case of the plaintiff, he was examined as PW1 and Ext.A1 to A3 got marked.

5. Heard the learned Counsel for the plaintiff.

6. On a perusal of plaint, proof affidavit and documents submitted the claim of the plaintiff to realize the money from the defendant remains unchallenged and undisputed. Since the defendant is proceeded ex-parte, the case of the plaintiff remains unchallenged. Hence, the suit is decreed as follows:-

The plaintiff is entitled to realize an amount of Rs.6,37,399/- (Rupees Six Lakh Thirty Seven Thousand Three Hundred and Ninety Nine only) with interest at 6% per annum from the date of suit till the date of realization. The plaintiff is entitled to get the costs of the suit from the defendant and his assets.

In the result, the suit is decreed with costs.
