The above case having come up for consideration on 30.05.26, this Court on the same day delivered the following:-

ORDER

The above case arose on a Final Report filed by Sub Inspector, Edachery Police Station Police Station in Crime No.724/25 alleging commission of offences punishable U/Ss.126(2), 115(2), 118(1), 110, 351(2) of Bharatiya Nyaya Sanhita.

2. The prosecution case is briefly stated as follows:- On 18.10.2025 at 20.00 hours, the accused who is the son of the Charge witness no.1, wrongfully restrained her from their house at Edachery Gramapanchayath and caused hurt to her by

treading and hitting on her body. Furthermore, the accused assaulted her with a wooden stick, threatened to kill her, and attempted to hit her on the head with the said wooden stick; however, she evaded the blow. If the said attack of accused was not evaded by her, it would have resulted in her death. Thereby, the accused alleged to have committed aforementioned offences.

3. Accused was arrested and produced before this Court on 21.10.2025 and remanded to judicial custody. The services of Asst. Defence Counsel was provided to the accused to defend him. Later he was granted bail by this court vide separate order in CMP. 4568/2025 dated 4.11.2025.

4. Since the final report disclosed commission of offences punishable U/Ss. 126(2), 115(2), 118(1), 110, 351(2) of BNS, one of which is exclusively triable by the Hon'ble Court of Sessions, committal proceedings were initiated against the accused.

5. On appearance, copies of all relevant prosecution records were furnished to the accused as contemplated under Section 230 of BNSS. He was permitted to continue on the bail bond executed during crime stage.

6. In the aforesaid circumstance, the case against accused is committed to the Hon'ble Sessions Court, Kozhikode U/s.232(a) of BNSS.

7. The Learned Public Prosecutor shall be notified of the commitment of the case.

8. Transmit the case records to the Hon'ble Court of Sessions, Kozhikode forthwith.

9. Property if any, will be submitted to Hon'ble Court on getting intimation.

10. The accused person is directed to appear before the Hon'ble Court of Sessions, Kozhikode, as and when required.
