The above case having come up for consideration on 8.4.26 and this Court on the same day delivered the following:-

ORDER

The above case arose on a Final Report filed by Sub Inspector of Police, Vatakara Police Station in Crime No.1469/25 alleging commission of offences punishable U/ss.329(4), 115(2), 296(b) of BNS and 92(b) of the Right of Persons with Disabilities Act, 2016.

2. The gist of prosecution case in brief is as follows:- On 15.10.2025 at 18.00 hours, the accused trespassed into the house of informant/CW1, having no. 19/11, 'Sankara Bhavanam' in Villiyapally Panchayath, and caused hurt to him and abused him using obscene language. CW1 is a person with disability. When CW2 tried to

interfere in the issue, accused caused hurt to him also. The cause of incident was preferring a police complaint against the accused for following his daughter. Thus, the accused is alleged to have committed the above offences.

3. On receipt of final report, this Court has taken cognizance for the above offences. Since the final report disclosed commission of offences punishable U/Ss.329(4),115(2),296(b) of BNS and 92(b) of the Right of Persons with Disabilities Act, one of which is exclusively triable by the Hon'ble Special Court, committal proceedings were initiated against accused.

4. On appearance, copies of all relevant prosecution records were furnished to the accused as contemplated u/S.230 of BNSS. Accused was permitted to continue on the bail bond executed during crime stage.

5. In the aforesaid circumstance, the case is committed to the Hon'ble Sessions Court, Kozhikode U/S.232(a) of BNSS.

6. The records as well as MO's shall be forwarded to the Hon'ble Sessions Court, Kozhikode forthwith.

7. Notify the learned Public Prosecutor, Kozhikode regarding the committal of the above case to the Hon'ble Sessions Court, Kozhikode.
