The above case having come up for consideration on 02.06.26, this Court on the same day delivered the following:-

ORDER

The above case arose on a Final Report filed by the Inspector of Police, Vatakara Police Station in Crime No.1346/25 alleging commission of offences punishable U/Ss.126(2), 87, 64, 351(2) of Bharatiya Nyaya Sanhita, 2023.

2. The prosecution case is briefly stated as follows:- The accused and the defacto complainant were studying together at Maniyoor ITI during the period from 2023 - 2025. On 29.08.2025 at 10.30 hours, the accused, with an intention to commit offence reached near the house of the defacto complainant and forcefully took her in his vehicle bearing no. KL 33 M 9767. At around 11.30 hours, they reached a hotel named Mahi Midas Sea View Hotel, at Mahi and he wrongfully restrained her and committed rape on her. The accused

further threatened her from disclosing the incident to others. Thus, the accused is alleged to have committed the above offences.

3. Accused person was arrested and produced before this court on 1.10.2025 and remanded to judicial custody till 15.10.2025 at Sub Jail, Vatakara. Later he was granted bail by the Hon'ble Sessions Court, Kozhikode, vide order in Criminal Miscellaneous Case no. 1505/25 dated 17.10.2025.

4. Since the final report revealed the commission of offences punishable under Sections 126(2), 87, 64, and 351(2) of the Bharatiya Nyaya Sanhita, two of which are exclusively triable by the Hon'ble Court of Session, committal proceedings were initiated against the accused.

5. On appearance of accused, copies of all relevant prosecution records were furnished to him as contemplated u/S.230 of BNSS and he was permitted to continue on the bail bond executed during crime stage.

6. In the aforesaid circumstance, the case against accused is committed to the Hon'ble Sessions Court, Kozhikode U/s.232(a) of BNSS.

7. The records/M.Os if any shall be forwarded to the Hon'ble Sessions Court, Kozhikode forthwith.

8. Notify the Learned Public Prosecutor, Kozhikode regarding the committal of the above case to the Hon'ble Sessions Court, Kozhikode.
