ORDER

1. This is a case charge sheeted by the Station House Officer, Balussery Police Station in Cr.No. 848/2025 against the accused alleging commission of offence punishable under Sections 75 (1) (i) of BNS.

2. The prosecution case in brief is as follows:- On 28.07.2025 at about 8.10 a.m., while the de facto complainant was travelling in bus bearing registration No. KL-58-U-7533 from Padikkal Vayal to Balussery, the accused, who was the

conductor of the bus, allegedly caught hold of her hand while receiving the fare and thereafter touched her hand and moved her forward and backward with sexual intent. Thus the accused committed the above said offences.

3. After filing final report in this case this court has taken the file as CP. 04/2026 and summons was issued to the accused. The accused appeared before the court on receipt of summons. The accused filed memo to continue the bail granted during crime stage and it was allowed. Copies of prosecution records were given to him and the requirements under section 230 of Bharatiya Nagarik Suraksha Sanhita (BNSS) is complied with.

4. Offence alleged against the accused is triable exclusively by the Hon'ble Court of Session. In the result, the case against accused is committed to the Hon'ble Court of Session, Kozhikode U/s. 232 (a) of Bharatiya Nagarik Suraksha Sanhita (BNSS) for trial.

5. The accused is on bail. He is directed to be appear before the Hon'ble Court of Session as and when directed U/S. 232 (b) of Bharatiya Nagarik Suraksha Sanhita.

6. The case records shall be submitted to the Hon'ble Court of Sessions U/s. 232 (c) Bharatiya Nagarik Suraksha Sanhita and the property produced if any, shall be sent subject to Rule 77 (2) of the Criminal Rules of Practice, Kerala.

7. The commitment of the case shall be notified to the Public Prosecutor, Kozhikode, U/S. 232 (d) BNSS.
