ORDER	:	The case against the accused is committed to the Hon'ble Court of Sessions, Kollam u/s. 232(a) of the Bharatiya Nagarik Suraksha Sanhita.

This case came up for hearing today, and the court delivered the following  
ORDER

This case arose on a final report filed by the Sub Inspector of Police,  
Railway Police Station, Kollam in crime No 430/2025 alleging commission of offence  
punishable u/ss.74, 75(1) (i) of the Bharatiya Nyaya Sanhita.

2. Prosecution case in brief is as follows: On 28.10.2025 while the  
defacto complainant was travelling in S1 coach of train No.16525 Kanyakumari-  
bangalore Express train at about 1.30 p.m, the accused, who was a co-passenger in the  
said train committed unwelcome physical contract with the defacto complainant and  
thereby outraged her modesty. Thereby the accused is alleged to have committed the

aforesaid offences.

3. On appearance of the accused, the copy of prosecution records were given to him u/s. 230 of Bharatiya Nagarik Suraksha Sanhita. The accused is on bail.

4. After perusing the prosecution records and after hearing both sides, it appears that offences alleged against the accused is exclusively triable by the Court of Sessions and hence case against the accused is committed to the Court of Sessions u/s. 232(a) of the Bharatiya Nagarik Suraksha Sanhita.

5. Send the entire case records to Hon'ble Sessions Court, Kollam as provided u/s. 232(c) of the Bharatiya Nagarik Suraksha Sanhita.

6. The committal of the case is notified to the Public Prosecutor, Kollam as provided u/s.232(d) of the Bharatiya Nagarik Suraksha Sanhita.

7. The accused is on bail. He is directed to appear before the Hon'ble Sessions Court, Kollam as and when required by that Court.

8. The material objects, if any shall be sent forthwith. The office is directed to sent the case records to the Hon'ble Sessions Court forthwith.
