**COMMITTAL ORDER**

1. This case was charge sheeted by the Sub-Inspector of Police Sakthikulangara police station in crime No. 360/2024 alleging the commission of offences punishable u/ss.294(b), 324, 308 IPC.

2. Prosecution case in brief is as follows : The accused on 22.04.2024 at about 11.30 p.m, uttered obscene words at CW1 and stabbed him on his neck using a knife. CW1 timely evaded and it got hit on his left shoulder causing deep injury. The accused again tried to stab him and he got deep injuries on his upper lips and chin. The accused is alleged to have committed offences punishable u/s.294(b), 324, 308 IPC.

3. On submission of charge sheet by SI of police, Sakthikulangara police station, the case was taken on file as CP 105/2024 for the aforesaid offences.

4. Copies of all relevant prosecution records were given to accused person and thereby mandate u/s.230 BNSS was complied with. The accused is on bail.

5. Heard. Perused records.

6. Since the offences alleged against the accused are exclusively triable by the Hon'ble Court of Sessions, this case is committed to the Hon'ble Court of Sessions, Kollam as provided U/s. 232 of BNSS.

7. Submit the records of the case, documents, articles U/s. 232 and property shall be sent subject to Rule 77(2) of the Criminal Rules of Practice, Kerala.

8. Notify the Public Prosecutor of the committal of the case to the Hon'ble Court of Sessions U/s.232 of BNSS.

The case against accused person is committed to the Hon'ble Sessions Court, Kollam u/s 232 BNSS.
