Charge : Offences punishable U/ss 296(b), 115(2), 109(1), 3(5), 118(1), 238(b) of the Bharatiya Nyaya Sanhita (BNS) 2023.

Order : Case against the accused is committed to the Hon'ble

Court of Sessions, Kollam under section 232 of BNSS.

ORDER

This is a prosecution case arising on the final report filed by Sub Inspector of Police, Pallithottam Police Station alleging that the accused committed the offences punishable u/ss. 296(b), 115(2), 109(1), 3(5), 118(1), 238(b) of the Bharatiya Nyaya Sanhita (BNS) 2023.

2. **The gist of the prosecution case is as follows:-** Due to the previous animosity between the friend of the defacto Complainant and the accused persons in this case, On 17.11.2025 at 7:45pm near at Thangassery Kochupilamoodu coastal road the de facto Complainant and his friends who are witness no. 2 to 6 in this case were standing near to the tar road and talking to each other, at that time the accused no 1 to 4 came on two bikes and shouted obscene words against the friend of the defacto complainant and the accused no 2 and 5 got off the bike and started pushing and fighting with the witness no 2 to 6. At that time the defacto complainant tried to stop the accused persons from attacking the witness no 2 to 4. Then the first accused who was sitting on the back of the bike of the second accused shouted obscene words against the de facto complainant and the first accused stabbed the first witness in the back of the neck with a knife like weapon in his hand and tried to kill him. Thereafter he caused the vehicle and the knife to be hidden in order to disappear the evidence. Thereby the accused no 1 to 4 is alleged to commit offences punishable under section 296(b), 115(2), 109(1), 3(5), 118(1), 238(b) of BNS.

3. Copies of all relevant prosecution records were furnished to the accused person. The accused person is on bail. I have perused the entire case records. The offences alleged to have been committed by the accused person are exclusively triable by the Court of Sessions. Hence the case against the accused is committed to the Hon'ble Court of Sessions, Kollam as provided u/s. 232 of BNSS. The accused no.1 absconded and hence the case against him was split up and refilled as CP 53/2025.

4. The Accused No: 4 filed a CMP 2/26 for permanent exemption which is pending in this case, is also committed along with case to the Hon'ble session court as per the 2nd proviso to section 232 of BNSS.
5. The accused person is directed to appear before the Hon'ble Court of Sessions as and when directed.
6. The office is directed to communicate to the Public Prosecutor about the committal of the case and to submit the case records to the Hon'ble Court of Sessions, Kollam and forward MO's as and when required.
