Charge : Offences punishable U/ss 75(1)(iv), 77, 78(1)(i) of the Bharatiya Nyaya Sanhita 2023.

Order : Case against the accused is committed to the Hon'ble Court of Sessions, Kollam under section 232 of BNSS.

ORDER

This is a prosecution case arising on the final report filed by Sub Inspector of Police, Pallithottam Police Station alleging that the accused committed the offences punishable u/ss. 75(1)(iv), 77, 78(1)(i) of the Bharatiya Nyaya Sanhita 2023.

2. **The gist of the prosecution case is as follows:-** On 08.08.2025 at 10:35 PM the accused who is the neighbour of the de facto complainant, with the intention to caused mental agony to the de facto complainant reached inside the residence of the de facto complainant and while the de facto complainant was changing her cloth

and took bath the accused peeked through the hole of the bathroom. Also the accused followed the de facto complainant in a scooter while she was going to work and made obscene gestures. Thereby the accused is alleged to have committed offences punishable under sections 75(1)(iv), 77 and 78(1)(i) of the Bharatiya Nyaya Sanhita, 2023.

3. Copies of all relevant prosecution records were furnished to the accused person. The accused person is on bail. I have perused the entire case records. The offences alleged to have been committed by the accused person is exclusively triable by the Court of Sessions. Hence case against the accused is committed to the Hon'ble Court of Sessions, Kollam as provided u/s. 232 of BNSS.

4. The accused person is directed to appear before the Hon'ble Court of Sessions as and when directed.

5. The office is directed to communicate to the Public Prosecutor about the committal of the case and to submit the case records to the Hon'ble Court of Sessions, Kollam and forward MO's as and when required.
