Charge : Offences punishable U/ss 115(2) and 103(1) of the Bharatiya Nyaya Sanhita (BNS) 2023.

Order : Case against the accused is committed to the Hon'ble Court of Sessions, Kollam under section 232 of BNSS.

ORDER

This is a prosecution case arising on the final report filed by Sub Inspector of Police, Kollam West Police Station alleging that the accused committed the offences punishable u/ss. 115(2) and 103(1) of the Bharatiya Nyaya Sanhita (BNS) 2023.

2. **The gist of the prosecution case is as follows:-** The accused, employed as a driver by CW14 in this case (who is the owner of Lake View Bar), developed animosity towards the victim following disputes over menial work and money demanded for food supplied to CW8 and CW9 in this case. On 06.09.2025 at about

11:30 PM, at the northern end of Lake View Bar, Thoppil Kadavu, Kollam where the accused assaulted the victim by striking hurt on the left cheek with his right hand of the accused. The victim fell down and sustained grievous head injuries, and was admitted to multiple hospitals, including Kollam District Hospital, Thevalli Hospital, KERF Hospital, Upasana Hospital, and finally Thiruvananthapuram Medical College Hospital. The victim was remained unconscious and ventilated until the death of the victim on 28.10.2025 at 3:15 p.m.

3. Copies of all relevant prosecution records were furnished to the accused person. The accused person is on bail. I have perused the entire case records. The offences alleged to have been committed by the accused person is exclusively triable by the Court of Sessions. Hence case against the accused is committed to the Hon'ble Court of Sessions, Kollam as provided u/s. 232 of BNSS.

4. The accused person is directed to appear before the Hon'ble Court of Sessions as and when directed.

5. The office is directed to communicate to the Public Prosecutor about the committal of the case and to submit the case records to the Hon'ble Court of Sessions, Kollam and forward MO's as and when required.
