This OP(MV) have been finally heard on 08.04.2026 and on the same day the Tribunal passed the following:-

AWARD

This is a petition for compensation filed under Sec. 166 of the Motor Vehicles Act, 1988.

During the pendency of the proceedings, petitioner and 3rd respondent arrived at an out of court settlement and filed a Joint Memo stating that the claim is settled for an amount of Rs. 3,50,000/- (Rupees three lakhs fifty thousand only) as full and final settlement. The 3rd respondent agreed to pay the amount within 60 days from the date of award. The parties sought for an award in terms of the Joint Memo. The Joint Memo is accepted and award is passed as follows:

(1) The petitioner is entitled to receive Rs. 3,50,000/- (Rupees three lakhs fifty thousand only) as compensation from the 3rd respondent within 60 days from today.

(2) The 3rd respondent is directed to deposit the award amount within 30 days from the date of this award and the amount shall be transferred directly to the credit of the bank account of the petitioner (Suni Baby), Indian Bank, Chengamanad Branch, Account No.8272584859, IFSC Code: IDIB000C046 through NEFT or RTGS or any Electronic mode as per the direction in the official memorandum No.

D1-1/62475/2016 dated 19-09-2025 read with Circular No. 1/25 of the Hon'ble High Court of Kerala.

(3) Joint Memo shall form part of the award.

(4) Parties shall bear their respective costs.
