Accused : Mahin S/o Faisal, aged 23/25, Farsana Manzil, Punayam, Palakkal, Ayirakkuzhy P.O, Kadakkal Village.

Offence : U/ss. 296(b), 333, 118(1), 351(2),110 of BNS.

Sentence/Order : Case against the accused is committed to the Court of Session, Kollam U/s.209(a) Cr.P.C.

This case coming on for hearing today, the court passed the following:

ORDER

1. This is a case charge sheeted by the Sub Inspector of Police, Kadakkal Police Station in Crime No. 121/2025 against the accused alleging the commission of offences punishable U/ss. 296(b), 333, 118(1), 351(2),110 of BNS.
2. The case of the prosecution is the following:- On 19.01.2025 at about 22.15 hours, the accused due to previous enmity towards CW1, criminally trespassed into the house of CW1 bearing number 08/83 situated in Kadakkal gramapanchayath. Thereafter the accused tried to stabbed on the neck of CW1 with a knife, she resisted with her hand, which she evaded, otherwise it would have resulted in her death. The defacto complainant sustained grievous hurt on her left wrist. Thus, prosecution alleges that the accused has committed the offence punishable under section 296(b), 333, 118(1), 351(2),110 of BNS.
3. The accused is on bail. On his appearance, the copies of relevant records relied on by the prosecution were furnished to him.
4. On a perusal of the available materials, it appeared to this court that the above case is triable exclusively by a Court of Session.
5. Therefore, the case against the accused is hereby committed to Court of Session, Kollam U/s.209(a) of Cr.P.C.

6. The accused is released on bail with direction to appear before the Court of Session, Kollam as and when called for U/s.209(b) of Cr.P.C.
7. The records shall be forwarded to the Hon'ble Sessions Court, Kollam and the property produced if any/shall be send subject to Rule 77(2) of the Criminal Rules of Practice, Kerala at the earliest.
8. The Public Prosecutor, Kollam shall be notified regarding the committal of the case U/s.209(d) of Cr.P.C.
