110, 190 of BNS.

Order : Case of accused (A1 to A6) is committed to the Hon'ble
Sessions Court, Kollam under section 232(a) of BNSS.

This case coming on for today's proceedings, the court passed the following:

ORDER

1. This case is taken on file upon a final report filed by the Sub Inspector of Police, Kannanelloor in Crime No. 523/2025 of Kannanelloor Police Station against the accused 1 to 6 alleging that they have committed offences punishable under sections 189(2), 191(2), 191(3), 126(2), 296(b), 115(2), 118(1), 110, 190 of BNS..
2. The prosecution case in brief is as follows:- The accused 1 to 6, on account of enmity towards the defacto complainant for questioning their acts of harassment towards the

defacto complainant's relatives at Kalakkal Paynada temple festival, in prosecution of their common object, formed themselves into an unlawful assembly, on 04.04.2025 at 10.30pm, wrongfully restrained the defacto complainant and uttered obscene words to his annoyance at Kuttanmukk junction in Nedumpana village. Furthermore, the first accused caught hold of defacto complainant's shirt, hit on the back side of his head with a rock piece, the second accused hit on the back of his head with an iron rod, the third accused punched on his neck, the 4th accused punched on his face, the first accused pulled the defacto complainant out of the autorickshaw and the 5th accused stamped him. Meanwhile the 6th accused hit on his left ear with an iron rod. Thus the accused 1 to 6 committed the aforesaid offences.

3. On appearance of the accused nos.1 to 6, the copies of relevant prosecution records were given to them u/s 230 of BNSS. The accused are on bail since crime stage and a memo has been filed to that effect.
4. After perusing the prosecution records and hearing both sides it appears that offences alleged against the accused are exclusively triable by the Hon'ble Court of Session and hence case against the accused is committed to the Hon'ble Court of Session u/s.232 (a) of BNSS.
5. Send the entire case records to the Hon'ble Sessions Court, Kollam as provided u/s. 232(c) of BNSS.
6. The commitment of the case is being notified to the Public Prosecutor, Kollam as provided u/s. 232 (d) of BNSS.
7. The accused no. 1 to 6 are directed to appear before the Hon'ble Sessions Court, Kollam as and when required by the Hon'ble Court.
8. The material objects, if any, shall be sent forthwith. Office is directed to sent the case records to the Hon'ble Sessions Court, forthwith.
