ORDER

The final report in this case was filed by the Sub Inspector of Police, East Kallada PS in Crime No. 765/2024 against the accused, for offences punishable u/s. 296(b), 126, 115(2), 351(2) of Bharatiya Nyaya Sanhita, 2023.

2. The prosecution case, in brief, is as follows :- The on account of his previous animosity against the defacto complainant, on 18.07.2018 at around 09.30 pm, at the building owned by Raju, Sheela Mandiram, restrained the defacto complainant, fisted him, kicked him, caught hold his neck and criminally intimidated him, thereby the accused has committed the offences alleged against him. The accused was arrested and released on bail. Thereafter the investigation was completed and final report was filed on 06.08.2024.

3. On filing final report, the case was mistakenly taken on file as CC 256/2024 and summons was issued to the accused without noticing the fact that the defacto complainant is a minor. The accused appeared before the Court and enlarged on bail. Copies of the prosecution records were furnished to him. After hearing both sides and after considering the prosecution records, charge was framed and read over to the accused to which he pleaded not guilty. Later, on realizing the mistake that the defacto complainant is minor, the case was refiled as CP 18/2026. As the case is exclusively triable by the Court of Session, it is committed to Hon'ble Court of Sessions, Kollam as contemplated under section 362 of Bharatiya Nagarik Suraksha Sanhita, 2023.

4. The entire records and material objects, if any, shall be forwarded to the Hon'ble Court of Sessions forthwith u/s 232(c) of the Bharatiya Nagarik Suraksha Sanhita, 2023. The accused shall appear before the Hon'ble Court of Sessions, Kollam as and when the Court directs.

5. Issue notice to the Public Prosecutor, Kollam regarding the committal of this case u/s 232(d) of the Bharatiya Nagarik Suraksha Sanhita, 2023
