Offence : u/ss 429 r/w 34 of IPC, 11(1) Prevention of Cruelty to Animals Act, 1960 and 50 & 51 of Central Motor Vehicles Rule, 1989.

Plea : Guilty

Finding : Guilty

Sentence/Order : Accused No. 1 to 4 are convicted and sentenced to pay a fine of Rs.1,000/- each only with default imprisonment for 10 days for the offences u/ss 429 r/w 34 of IPC, 11(1) Prevention of Cruelty to Animals Act, 1960 and 50 & 51 of Central Motor Vehicles Rule, 1989.

J U D G M E N T

This is a case in which final report has been filed by the Sub Inspector of Police, Sooranadu Police Station in Crime No.864/2023 against the accused No. 1 to 4 alleging offence punishable u/ss 429 r/w 34 of IPC, 11(1) Prevention of Cruelty to Animals Act, 1960 and 50 & 51 of Central Motor Vehicles Rule, 1989.

2. The accused No. 1 to 4 appeared through counsel. They were given copy of all prosecution records. Thereafter the particulars offences were read over and explained to the accused, to which they pleaded guilty. It is accepted as it is seen to be voluntarily made knowing of its consequence. So accused No. 1 to 4 are convicted for the above said offences.

In the result, accused No. 1 to 4 are convicted and sentenced to pay a fine of fine of Rs.1,000/- each only with default imprisonment for 10 days for the offences u/ss 429 r/w 34 of IPC, 11(1) Prevention of Cruelty to Animals Act, 1960 and 50 & 51 of Central Motor Vehicles Rule, 1989.
