This petition coming on for hearing on 18.02.2026 and on the same day the court ordered the following:-

ORDER

Perused the affidavit in support of injunction petition, plaint and documents. I am satisfied that a prima facie case is made out justifying the grant of an ad-interim order of injunction. Prima facie, the balance of convenience is found in favour of the petitioner/plaintiff. If interim order is not granted, irreparable injury is likely to be caused to the petitioner/plaintiff. Delay in sending the notice will defeat the object of granting the relief. Hence, respondents/defendants and men under them are restrained from trespassing

into the plaint schedule property or committing any mischief or waste therein other than due process of law until further orders.
