ORDER

Petition filed under order XXXIX Rule 1 C.P.C

Heard and perused the records. I am satisfied that the pleadings and materials on record disclose a prima facie case. Balance of convenience is also in favour of the plaintiffs and irreparable injury and loss would be caused to the plaintiffs if injunction is not granted. Having gone through the nature of the reliefs sought for, it seems that issuance of notice would defeat the purpose of the suit. So, the defendants and men under them are restrained from committing any mischief in the plaint schedule property, from demolishing its boundaries, from taking vehicles into the plaint schedule property and from parking vehicles in the plaint schedule property until further orders.
